Paid At the request of Caspar Winkler this Deed was recorded July 28<sup>th</sup> 1863  
This Deed, made this 6<sup>th</sup> day of June in the year of our Lord one thousand eight hundred and sixty two, by Bartholomew Winkler and Catherine Winkler, his wife, Witnesseth: that in consideration of the sum of three hundred and fifty dollars, current money the said Bartholomew Winkler and Catherine Winkler do grant, in fee simple, unto Caspar Winkler all that piece or parcel of land lying and being in Allegany County, and State of Maryland, being part of a tract of land called "The Resurvey on Hoffmann's Delight" & which is described as follows: Beginning at a stake standing on Nobley Mountain about twelve rods to the northwest of Howland's Park and running thence North twenty seven and a half degrees West fifty feet, North fifty & a quarter degrees East three hundred and thirty feet, South twenty seven and a quarter degrees East, fifty feet thence by a straight line to the beginning, Reserving the right of opening a street across said lot thirty feet in width, at the distance of about sixty six feet on the second line of the same: which said piece or parcel of land was originally conveyed by George Blocher to Williams Keesner by deed dated November 26<sup>th</sup> 1842 and recorded in Liber A. B. No. D. D. folio 82<sup>o</sup> &c. one of the Land Records of Allegany County, Maryland, and by Williams Keesner to Conrad Aab by deed dated the 28<sup>th</sup> day of October 1843 & recorded in Liber A. B. No. D. D. folio 58<sup>o</sup> &c. one of the Land Records as aforesaid: and by said Conrad Aab to Bartholomew Winkler by deed dated the 9<sup>th</sup> October the 9<sup>th</sup> 1844 and recorded in Liber A. B. No. C. C. folio 482<sup>o</sup> &c. one of the Land Records of the County aforesaid,
